1. Registration of at least one co-author of accepted paper is mandatory.
2. Papers which have been accepted and there is no paid registration corresponding to any author, respectively, will be excluded from the proceedings.
3. For each accepted paper at least one author should register and pay to the conference.
4. Additional accepted paper by the same author will be charged additionally 250 euros.
5. Each registered author may present up to 3 Full Papers that he has co-authored.

IMPORTANT! PLEASE NOTE THE FOLLOWING GUIDELINES:

- A. All early bird registrations must be completed before end of **11th June, 2018, local time**. Any registration received after this date will be processed with a Regular fee. If you expect or experience a delay for technical or other force majeure reasons, please contact the organizers as soon as possible by e-mail: icimth@outlook.com. In addition, please write REGISTRATION to the subject of the mail.
- B. A scanned copy of the bank order transaction (or a printout for e-banking) must be sent to icimth@outlook.com in order to complete your registration. In addition, do not forget to mention the justification on your bank order.
- C. Delegates who require a formal receipt or invoice for paying the conference fee are kindly advised to provide us with all the necessary information (e.g. name, institution, tax registration number, etc.), by e-mail (icimth@outlook.com), at the time they make the bank transfer. Receipts and invoices will be issued by the University and will be available to collect them during the conference at the registration desk.
- D. Fees are not refundable in case of cancellation or no-show.
- E. If you need to register more than one persons, please proceed as follows:
 - a. An author or delegate should register any accompanying person(s) by using a single form for each person; there is no limit on the number of the accompanying persons per delegate. Please mention "Accompanying person" in the affiliation field of the registration form.
 - b. Different authors or delegates should complete separate forms, even when co-authoring the same paper.
 - c. The registration rule for authors is "at least one registered author for each paper accepted for presentation and proceedings". For more details refer to Conditions 3 and 4.
